

## PRIVACY POLICY

At Bronco Wine Company, we are committed to protecting your privacy. The following statement describes the information gathering and usage practices of Bronco Wine Company.

We may collect personal information from you, such as your name, email address or date of birth, when you visit this web site (the "Web Site") or one of our affiliated Bronco web sites, including Bronco Wine Company and Classic Wines of California; or when you download any of the images, graphics or text material ("Material") on the Web Site or email us with a question or concern.
